# PONTHIR COMMUNITY COUNCIL CYNGOR CYMUNED PONTHIR

## Minutes of Monthly Meeting Held on 10<sup>th</sup> July 2013

- Present: Cllr. R. Davies(Chair), Cllr. T Roberts, Cllr. Mrs J. Morgan, Cllr. S. Bailey, Cllr. Mrs J Bold Members of Public Attending: 1 resident attended the meeting from 7.45pm Clerk: Karen Price
- **2. Apologies:** Cllr. P. Matthews and Sarah Ibrahim (Gwent Police). Cllr. H. Bevan (Torfaen CBC) had informed Chair that he would be attending but might be late.
- **3. Declarations of Interest:** Cllr. Davies declared an interest in item 15 as he is the Council's representative on Ponthir C in W School's Board of Governors. Cllr. Davies conveyed what Mrs. Spooner had asked for and took no part in the discussion to consider the request.
- 4. <u>Police Report</u> Council expressed disappointment that once again there was no police presence at this meeting and it was noted that the last time a member of Gwent Police had attended a Council Meeting was on 13<sup>th</sup> February 2013. Once Clerk had received PCSO Ibrahim's apologies she had requested that another officer attend but had not received a response. Council noted the contents of PCSO Ibrahim's e-mail concerning the last PACT Meeting particularly the report of criminal damage in The Orchard as none of the Councillors present knew of this incident. PCSO Ibrahim reported that there had been 29 Anti-Social Behaviour incidents since last year. Clerk had also asked for the details of the traffic accident in Llanfrechfa but PCSO Ibrahim number. (Action: Clerk to write to Insp. Blakemore and Acting Chief Constable concerning the lack of attendance by officers at the Council's meetings and requesting information about the traffic accident in Llanfrechfa)
- 5. <u>Report From Cllr Huw Bevan, Torfaen CBC</u> None Received.
- **6.** The minutes of the Meeting held on the 12<sup>th</sup> June 2013 were approved as a true record and duly signed. Proposed by Cllr. Roberts and seconded by Cllr. Morgan.
- 7. <u>Matters arising from the minutes of the Meeting held on 12th June 2013</u>
  - a. <u>Clarification of the effect of the Dog Control Orders on the Sports Field –</u> Cllr. Bevan, Torfaen CBC, has written to Torfaen CBC but Council has not received any further information.
  - b. **Future Maintenance Arrangements of the Sports Fields** The Sports Club has confirmed that as part of the new lease the Sports Club will have to maintain the fields itself. There are two issues regarding a Tree Preservation Order and water leak that the Club wishes to clarify before signing the new lease.

- c. <u>Shortage of Wheelie Bins in Torfaen CBC –</u> Torfaen CBC issued a press release on 24<sup>th</sup> June to confirm they now have a supply of bins.
- d. <u>Telephone Kiosk, Tram Lane</u> Clerk has been in touch with Western Power and SWALEC. Council approved the agreement form from Western Power to supply a new MPAN number. (Action: Clerk to proceed to make arrangements for an electricity supply to be reconnected to the Kiosk)
- e. <u>War Memorial Budget –</u> Clerk confirmed that the Power of Well Being would enable the Council to consider contributing towards any request that may be received from Torfaen CBC for a contribution towards the maintenance of a War Memorial outside our community area (Action: Clerk to make enquiries with the other local community councils to gage levels of contributions)
- f. <u>Village Planters Cllr</u>. Matthews has planted all the planters in Ponthir and Llanfrechfa. Residents in Llanfrechfa have volunteered to water those in Tram Lane and Mrs Amanda Morgan, Lamb Lane, has offered to water those at the bus stop opposite Lamb Lane. The remaining planters are being watered by members of the Council.
- g. <u>Filing Cabinets</u> These are still to be moved to Cllr. Bailey's home. Council noted that some of the files in the cabinets have been emptied. (Action: Chair to contact Jenny Nancarrow)
- h. <u>Audit 2012/2013 –</u> This has been sent to the external auditor.
- i. <u>Grants –</u> Chair has spoken to Iain Glover, Ponthir Sports Club concerning their request for assistance in purchasing new mowers.
- j. <u>Possible improvements to Ponthir & Llanfrechfa –</u> Cllr. Roberts has met with Steve Horsman, Torfaen CBC, to discuss possible improvements to the appearances of the entrances to Ponthir and Llanfrechfa. Cllr. Roberts is arranging to meet with Julia Miller, Torfaen CBC, to discuss possible sponsorship by local businesses similar to many of the roundabouts in Cwmbran. Council noted that there was still £500 remaining in the budget for the planters that could be used towards the planting of daffodils in the autumn. It was noted that there would be an ongoing maintenance cost for this scheme. Initially Council had been looking at the entrances to Ponthir & Llanfrechfa but it was also agreed to look at other sites that could be improved (See Item 12). Council noted that there are raised boarders in Longbridge which Bron Afon maintain and asked if these could be looked at for improvement. (Action: Cllr. Roberts to come back to Council with possible designs and updates. Cllr Bailey to find contact details for Bron Afon)
- k. <u>South Wales Programme Consultation Aneurin Bevan Health Board –</u> Cllrs. Davies & Morgan unable to attend the meeting held in Cwmbran.
- Publication of a newsletter for Ponthir & Llanfrechfa Chair has received quotes from Davies Printers, Designer Print and That Media Group. Council noted the wide variation in quotes between the three companies. Council agreed the decision was between either Designer Print or That Media Group and they should both be asked to provide a sample template for the next Council meeting. Council discussed possible content of any first publication. Suggestions included contact details of Councillors and Clerk, details of Community Council Grants and details of Police Meetings in Ponthir. (Action: Chair to contact Designer Print and That Media Group)

Resident entered the meeting at 7.45pm.

- d. <u>Payroll Agreement from Torfaen County Borough Council & Completion of</u> <u>Standing Order Mandate for Clerk's Salary</u> – Council noted the contents of the Payroll Agreement with Torfaen CBC and approved its completion. Chair informed Council that Torfaen CBC Payroll Dept. had overpaid the Clerk in June and that despite contacting them he had still not had a response. It was agreed that the standing order mandate would not be completed until the necessary correcting entries had been made in July. (Action: Chair & Clerk to sign the payroll agreement. Chair to contact Torfaen CBC Payroll Dept.)
- Model Contract of Employment for Clerk Chair has circulated the model contract of employment from One Voice Wales to all Councillors. (Action: To be discussed at the next Council Meeting)
- 10. <u>Chair's Report –</u> Chair read out a letter he had written to Mr Bubela, Ponthir Village Hall concerning the Council re-engaging with the Village Hall Committee and his ideas for a joint village event this Christmas. Mr Bubela has confirmed that this will be discussed at the next Village Hall Meeting. Cllr. Roberts highlighted the fact that the Council needs to have a permanent postal address (Action: Chair to make enquiries about a postal address)
